If you enjoy a walk in a local park, the thrill of growing your own fruit and vegetables or just love being outside in your own garden, you will understand why having access to the natural environment is so important.

And yet these green spaces are not available to everyone, countless children do not have a safe place to play outdoors, many communities don't have a local green space to bring them together and many people find themselves indoors and isolated.

This is why the work of The Conservation Volunteers (TCV) is so important as we work each day to create green spaces in the heart of UK communities.

By choosing to leave a legacy to us in your Will, you are empowering and inspiring more volunteers to what's inspired you in your lifetime.

On behalf of The Conservation Volunteers please know that every penny donated to us is gratefully and carefully spent – **thank you.**

If you are altering an existing Will by adding a Codicil or if you wish to draw up a new Will, we advise you to seek professional advice from a solicitor.

Below is suggested wording for your legacy:

For a pecuniary legacy: (the gift of a fixed sum)

I give to **The Conservation Volunteers, Head Office, Sedum House, Mallard Way, Doncaster DN4 8DB, Registered Charity Number 261009** (*hereinafter called 'the Charity'*) the sum of £..... (*amount of the legacy*)free of Inheritance Tax, such sum to be applied to the general purposes of the Charity towards the promotion of its objects and I direct that a receipt of the Honorary Treasurer or other authorised officer for the time being of the Charity shall be a good and sufficient discharge to my Executors for the payment of the aforesaid legacy.

For a residuary legacy: (a percentage of the remainders)

I give devise and bequeath all (*.....% or a share of%*) residue of my estate absolutely to **The Conservation Volunteers, Head Office, Sedum House, Mallard Way, Doncaster DN4 8DB, Registered Charity Number 261009** (*hereinafter called 'the Charity'*) such sum to be applied to the general purposes of the Charity and I direct that a receipt of the Honorary Treasurer or other authorised officer for the time being of the Charity shall be a good and sufficient discharge to my Executors.



Charity merged or no long in existence

Please note that the wording of these clauses (a&b and charity name change) may not be suitable for inclusion in every Will.

If at the date of my death the charity named in clause [insert clause number] (**Original Charity**) no longer exists or has been wound up, my trustees must:

- a) If the **Original Charity** has merged or is about to merge with another charity (**Recipient Charity**) and the merger when completed, is registered in the official register of mergers maintained by the charity commission, pay the Recipient Charity the amount specified in clause [insert clause number] as being payable to the Original charity or
- b) If sub clause (a) above does not apply, pay the amount specified in clause (insert clause number) as being payable to the **Original Charity** to another charity that has objects similar to the **Original Charity**.

Charity has changed its name

If before my death (or after my death but before my trustees have given effect to the gift) any charitable or other body to which a gift is made by this Will or any Codicil to it has changed its name then my trustees shall give effect to the gift as if it were a gift to the body in its changed name.

By choosing to leave even a small legacy to The Conservation Volunteers in your Will, know that together we can make a real and lasting difference.
